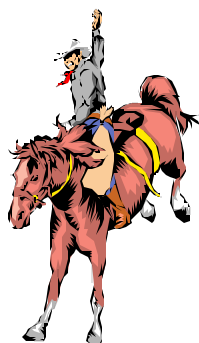

Great News! Transportation, as mentioned in the last general membership meeting, has been secured for the 2003 Road Runner Regional Rodeo with Gray Line Tours. The buses will be the same as last year - charter-style buses. Below is a listing of preliminary pickup times for the charter bus service.

Friday, January 17th: First pickup from Charlie's at 4:00pm and the last bus will pick up from Charlie's at 3:00am

Saturday, January 18th: First pickup from Charlie's at 6:15am and the last bus will pick up from Charlie's at 3:00am

Sunday, January 19th: First pickup from Charlie's at 6:15am and the last bus will pick up from Charlie's at 1:00am

Note: The times listed above are only for the first pickup and the last pickup of the day. Other locations, such as hotel stops will be published at a later date.

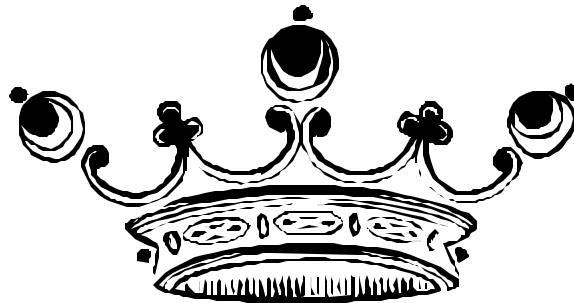

Dear AGRA Executive Board, Board of directors, and Membership;

I am writing this letter in response to the Certified Return Receipt Letter sent to me On November 5th, 2002. I was publicly embarrassed by the 2002 AGRA Vice President, and the 2002 AGRA Executive Board for allowing this "so called" Removal of Royalty Title to occur. This occurred during the Sunday, November 10, 2002 Membership Meeting at Charlie's Bar - a Public Place.

First off I would like everyone to be aware that in the last month, I have been in and out of the hospital due to my health. This was apparent to the Board, as I had received a \$50.00 check from the Board and A.G.R.A Membership during one of my Hospital Visits. This was, at the time ! very thoughtful. I had no less been released from the Hospital when I became aware, that there was possibly an action taking place to remove me of my 2002 Miss AGRA 1st Runner Up Title. I had been released from the Hospital Friday, November 08, 2002. I had not even received this "Letter" until after the meeting occurred.

The letter states that the reason for this decision was: **"I had not renewed my membership fees, and was no longer a Member in Good Standing."** It continues to state: **"according to the By Laws, that I am required to remain a "Member in Good Standing" to retain my title."** I took this opportunity to review my copy of the newest Bylaws. Please review with me:

Section VIII A.G.R.A. Royalty

8.2 Eligibility for Competition:

A.) Must be an AGRA member in good standing for a minimum of thirty (30) Days before announcing his/her candidacy.

The above requirement is for someone announcing their candidacy for competition. This is the only section in **VIII** that makes any reference to "member in good standing". I am not a candidate for AGRA Royalty 2003, so this requirement does not pertain to myself.

Section 8.8 Retention of A.G.R.A. Royalty Title:

A) All title holders and runners-up must demonstrate a good faith effort within 90 days of competition, towards the accomplishment of their duties according to the Bylaws. (i.e., Raising 25% of the required funds or representing their title at an I.G.R.A. sanctioned event or function).

B) Each title of Mr. Mrs. Miss are required to attend a minimum of six (6) membership meetings within the first 9 months of their reign.

C) To retain the title of Mr/Mrs/Miss A.G.R.A. of Runner-up, the individual:

1)! Must reside in the state of Arizona throughout his/her reign.

2) If an individual who has the title of Mr/Mrs/Miss A.G.R.A. moves out of the state of Arizona, resigns the title for any reason, or has the title removed for any reason, the individual with the 1st Runner-up title assumes the respective title.

D) Each title holder (Mr/Mrs/Miss and all Runner-ups) are required to raise a minimum of two-hundred-fifty dollars (\$250.00) during their reigning year for A.G.R.A. operating expenses.

E) The Mr/Mrs/Miss A.G.R.A. shall be expected to attend at least two (2) out of state I.G.R.A. sanctioned functions or events during their reign (i.e. Rodeo's, I.G.R.A. convention, I.G.R.A. University)

F) A.G.R.A. runner ups shall make every effort to attend at least one (1) out of state I.G.R.A. sanctioned function or event during their reign.

G) The Mr/Mrs/Miss A.G.R.A. shall be expected to attend and compete in the I.G.R.A. competition for the respective I.G.R.A. title.

H) A.G.R.A. shall pay entry fees for Mr/Mrs/Miss A.G.R.A. to compete in the I.G.R.A. competition.

More Royalty News...

According to the Bylaws, there is no reference of a requirement to retain membership in order to retain a Royalty title. Also, section **8.10 "Discipline"** verifies you did not follow this Bylaw procedure. I ask you to reference that section in your bylaws as well.

8.10 Discipline:

A) Any individual may submit in writing to the Vice President why he/she believes discipline is justified. Reasons shall be for, but not limited to:

- 1) Unbecoming behavior or unethical conduct as determined by the Executive Board.
- 2) Fighting
- 3) Intentionally subjecting A.G.R.A. or I.G.R.A. to bad publicity, verbal or written.
- 4) Excessive abusive language, gestures, or intimidation of any kind.
- 5) Disorderly conduct at any A.G.R.A. or I.G.R.A. function

The above reasons make no reference to not renewing membership.

VIII 8.10 C) The Process for discipline shall be:

Reference items # 1-# 5

1) The Vice-president shall issue a verbal warning for a first offense.

If there was a letter written to the Vice President, regarding membership expiration, the Bylaws explain the Vice President shall issue a verbal warning for the first offense. Being I was in the Hospital, this did not occur. This "Verbal Warning" is required by the Bylaws to be submitted to the A.G.R.A. Secretary within 5 days after the verbal warning occurs. VIII 8.10 C) #2

It states after a second offense, a Certified Return Receipt Letter is to be mailed to the Individual(s) within 5 days after the second offense occurred. VIII 8.10 C) #3 There was no second offense, and no Certified Return Receipt "Letter of Reprimand" sent to myself.

Only subsequent actions after a second offense is the Vice President to request a Special Board Meeting for review of subsequent actions. VIII 8.10 C) #4 It states that the affected candidate or title holder shall be notified of the "special board meeting" at least ten (10) days in advance. VIII 8.10 C) #5 a)

A return Receipt Letter was signed for by myself on November 15, 2002 and was dated November 5th, 2002. This shows the 2002 A.G.R.A. Vice President and the 2002 A.G.R.A. Executive Board have violated my rights as a member, and a Royalty Title holder as 2002 Miss A.G.R.A. 1st Runner-up. You have violated the newest updated Bylaws, and have personally embarrassed myself not only in front of the Membership, but in front of the Public in a Public Place.

It appears that the 2002 A.G.R.A. Vice President and the 2002 A.G.R.A. Executive Board need to review this situation and correct it immediately, including the rescission of this decision, the immediate return of my title, and a public apology to myself for the embarrassing situation that in no way is supported by the 2002 A.G.R.A. Bylaws.

REGARDING THE BOARDS' DECISION: ONE EXTREMELY IMPORTANT BY LAW WAS OVERLOOKED BY JOHNNY HAYES WHICH WAS USED IN THE BOARDS DECISION:

PAGE 6 Section 4.4, B 4: Timely payment of annual dues for membership renewal is ***required*** to ensure the members eligibility to ***RETAIN*** and/or run for A.G.R.A. offices and or ***Royalty*** and to participate in I.G.R.A. Rodeo's.

This Bylaw is under "Initiation Fees and Membership Dues" for a reason. If this Bylaw is not met, which it was not met by Johnathan Hayes (a.k.a. Miss Sassy), then the Royalty Bylaws and any others cited by Johnathan in the above letter are null and void, as he was no longer a member of A.G.R.A. After receiving the letter of explanation concerning his title from Patrick Lose, dated Nov 5, 2002. Johnny Hayes still did not renew his membership until the night of the membership meeting Nov 10, 2002.

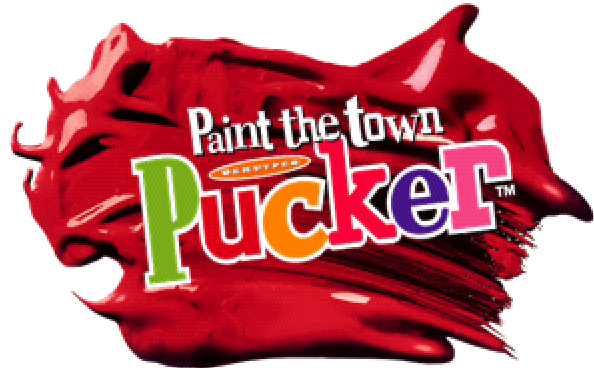
