

Nominations will again be receive in the June 12 Membership Meeting, and voting by secret ballot will take place in the July 17 Membership Meeting. The AGRA President and Trustee are automatically Delegates. The four people receiving the highest number of votes will be Delegates, and the five people with the next highest number of votes will be Alternate Delegates.

Nominations for International Awards will be accepted in the June 12 Membership Meeting. Award categories are International Award, Trustees' Award, and Appreciation Award. The IGRA Board of Directors and Trustees select the recipients for the International and Trustees Awards. The Appreciation Award is for non-members of IGRA, and IGRA pays for two awards per Member Association. If there are more than two nominations for the Appreciation Award, I will suggest members vote so that only two AGRA Appreciation Awards are given.

International Awards descriptions are:

International Award

This award is to recognize those members of IGRA who have made contributions to IRA worthy of special recognition. This contribution can be in any of the activities that IGRA encompasses.



Trustees' Award

This award is to recognize those contestants of IGRA who have exhibited excellence in the standards exemplified in the Code of Ethics and Sportsmanship.

Appreciation Award

This award is for non-members of IGRA who have made significant contributions to the association and is a means of providing a formal "thank you".
